- 1. That my admission is not a right but a privilege, which is subjected to my agreement, in good faith, with this contract and the rules and regulations that govern the religious, moral, social, and academic ideals of the college and the student's conduct and behavior of NLAC;
- 2. That I will read the existing rules and regulations of NLAC carefully and subject myself, without any reservations, to such rules and regulations as stipulated in the Student Handbook and to any rules and regulations that after this may be promulgated and announced through written or verbal means during duly called meetings of the college;
- 3. That I will obligate myself, prompt, cheerful, and courteous in attending all religious, social, and academic programs of the college and their substitutes when there are any;
- 4. That I will wear appropriate attire and deportment in conformity with the Seventh-day Adventists' dress and adornment standards in attending all religious, social, and academic programs of the college;
- 5. That I authorize the college to send my grades to my parents, guardian, financial sponsor, or scholarship grant sponsor;
- 6. That during my collegiate stay at NLAC, I will not join and/or be actively involved, if affiliated already, in any social fraternities and sororities as to its promotion, recruitment, initiation, and any related activities of such organization. - 8. That I will exercise decency in all my social media postings and not engage in bullying or cyberbullying in any form;
- 9. That I will not smoke cigarettes, vape, or drink alcoholic beverages within the immediate vicinity of the college or even beyond when wearing the school uniform and/or ID card;
- 10. That I will not use or push prohibited drugs while a student of the college;
- 11. That I will not practice any form of sexual harassment, which is a violation of RA 7877 and RA 11313;
- 12. That should I be found guilty after due process of violating any rules and regulations of the college as stipulated in this contract and/or the Student Handbook, I will subject myself to the penalty of such violations and unconditionally recognize the college's authority to impose the stipulated penalty; and
